3. Non-Conforming Tent Structures

Mr. Dunakey informed the Council that he and the Building Inspector had conducted inspections of each of the non-conforming tent structures throughout the City and one of the facilities has deficiencies with four of the seven life safety issues. Mr. Dunakey then inquired as to how staff should proceed with the situation. Mayor Hutchinson inquired if the four violations were correctable, to which Mr. Dunakey verified they can be fixed. City Administrator Morani stated that it is staff's position to revoke the City's deferral of building code enforcement pertaining to this structure since it has not been brought into compliance with life safety items. It was the consensus of the Council to issue a letter revoking the City's deferral of building code enforcement for the tent structure.

A. Deputy Clerk Vacancy

Mr. Morani explained the City intends to backfill the vacancy that will be created by appointing Kelly Mathews as the new Deputy Clerk upon Donna Mehaffey’s retirement. Mr. Morani added the City received over 50 applications for the clerical position at the Police Department and he will be reviewing those applicants for potential candidates for the Clerk’s Office. Mr. Morani also stated several employees will be cross-trained for City Hall clerical and administrative activities. Alderman Roessler inquired if the City is still considering eliminating the full-time Deputy Clerk position. Mr. Hoeffken explained that he and Mr. Morani are still reviewing options to maximize all City Hall personnel responsibilities, but added while it is not a full-time job, there will always be a need for a Deputy Clerk to exercise the activities of the City Clerk in their absence.

B. POP-UP SHOP Monument Sign

Alderman Roessler stated he would like to either table action on the POP-UP SHOP monument sign or discuss it at the next Committee Meeting. Mayor Hutchinson stated the topic will be added to the agenda for the Committee of the Whole meeting. Alderman Niemietz stated the size of the sign is a major issue and suggested a mock-up sign be erected on the site so the Council can see the impact to the area.

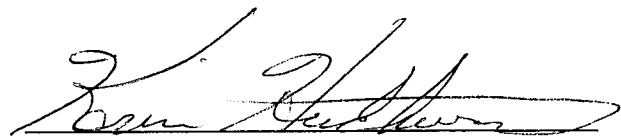
