

ORDINANCE NO. 3472

AN ORDINANCE APPOINTING DOUGLAS R. BRIMM AS CITY ADMINISTRATOR, BUDGET OFFICER AND HEALTH OFFICER OF THE CITY OF COLUMBIA, ILLINOIS, EFFECTIVE SEPTEMBER 9, 2019, AND ESTABLISHING THE ANNUAL SALARY FOR THOSE POSITIONS

WHEREAS, pursuant to City of Columbia, Illinois (“City”) Ordinance No. 3463, approved by the City Council on May 20, 2019, Albert G. Hudzik was appointed to the City Offices of Interim City Administrator, Budget Officer and Health Officer (effective May 6, 2019, until appointment of a City Administrator) by the Mayor with the advice and consent of the City Council; and

WHEREAS, pursuant to City Ordinance No. 3460, the salary of the City Administrator, Budget Officer and Health Officer, as well as the allowance to reimburse the office related expenses of those positions, was approved by the City Council on April 15, 2019; and

WHEREAS, after receiving applications and conducting interviews for the City Administrator’s position, on August 5, 2019 the City Council approved City Resolution No. 2019-17, which approved an Employment Agreement for Douglas R. Brimm (“Brimm”) to serve as the City’s next City Administrator (“Employment Agreement”), which Employment Agreement has an effective date of September 9, 2019; and

WHEREAS, said Employment Agreement contains provisions setting the salary and expense reimbursements due Brimm for serving as City Administrator.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

Section 1. Appointment of Douglas R. Brimm to City Offices

Douglas R. Brimm is hereby appointed as the City Administrator, Budget Officer and Health Officer of the City of Columbia, Illinois, effective September 9, 2019.

Section 2. Salary/Benefits of Douglas R. Brimm

Effective September 9, 2019, and pursuant to the terms and provisions of the Employment Agreement (i) the salary of Douglas R. Brimm in his capacity as City Administrator, Budget Officer and Health Officer of the City of Columbia, Illinois, is hereby changed from the amount appearing in City Ordinance No. 3460 for those offices, to an annual

amount of \$98,500, until otherwise changed by ordinance; and (ii) the benefits and reimbursements due Douglas R. Brimm shall be as set forth in the terms and provisions of the Employment Agreement and the City's Municipal Code.

Section 3.

All ordinances, resolutions, or orders of the City in conflict herewith, to the extent of such conflict, are hereby repealed.

Section 4.

This ordinance shall be in full force and effect from and after its passage and approval, as provided by law.

Alderman Niemietz moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:
