2. Meyer Lake Subdivision

Considerable discussion involving all Council members, the Mayor, City Attorney Tom Adams and Mr. Greg Meyer occurred regarding a proposed ordinance for conditional approval of the Minor Subdivision Plat for the Meyer Lake Subdivision, a four lot subdivision located on Ghent Road in the City. After listening to various opinions during the discussion and after being advised of the variances required for plat approval and the need for a public hearing for the zoning code variance by Attorney Adams, the consensus of the Council was not to act on the proposed ordinance at this time.

3. Diehl Plaza Drainage Issue

The Council discussed a request and information from Mr. Mark Wegmann requesting the City's participation in dealing with a drainage issue along North Main Street and Diehl Plaza. The proposal from Mr. Wegmann included an equal cost share between himself and the city.




