5. Invoice from IDOT for Bottom Avenue Project

After discussion about the \$37,307.09 payment due to the Illinois Department of Transportation for the Bottom Avenue Project, it was noted the monies are owed IDOT; however it was not clear how the monies are to be taken out of the current budget since the amount was not budgeted this year. It was in the budget in previous years and was recommended payment be taken out of the Capital Development Fund. It was the consensus of the Council to have Mr. Hudzik and Ms. Sharp research how the City is to proceed to pay the invoice out of the current budget, if an ordinance has to be approved and may contact City Attorney Adams for guidance, if needed.

6. Authorization to Order Materials for Route 158 Water Line Relocation Project

After discussion and a straw poll of the Aldermen, it was the consensus of the City Council for Mr. Williams to go ahead and order the materials for the Route 158 Waterline Relocation Project. This action will save time by one and one-half weeks and the project still has to be formally approved with an ordinance.

Miscellaneous

Mr. Williams also discussed the Developed Area Map for AR Zone, the Old Town Project and the Milton Street project per his written report. The Crimm driveway issue on the Old Town Project has been resolved, but the Devenport driveway issue is still under discussion. Fire Chief Roediger requested road closures in Old Town for emergency vehicles. Mr. Williams and Mr. Hudzik will get information to the newspapers for the detour area speed limits in the Old town Project. Mr. Adams reported that Parcel 9 on the Milton Street Project was signed. It is Mr. Craig Hiser's goal of CMJP Properties, Inc. to have remaining parcels acquired by the end of September, 2009.

2. Police Department Air Conditioner Unit/Duct Work Bids

Mr. Hudzik stated that the Police Department Air Conditioner is 25 years old and that he obtained bids for the duct work and the air conditioner unit. The Vogel bid was the low bid, but the a/c unit is an Amana unit. Mr. Williams researched the Amana unit and it is similar to the Trane and Carrier brands. It has a good warranty of five years parts, but the negative was that there was noise and vibration from the unit. The Trane and Carrier brands are more of commercial brands. It was recommended by Aldermen Agne and Oberkfell to go with the Carrier brand unit which is also a quieter unit. It was also decided to get the economizer operation in addition to the a/c unit and duct work. This was bid under Doll, Inc.
