AN ORDINANCE AMENDING SECTION 15.08.020 (ADDITIONS, INSERTIONS AND CHANGES) OF CHAPTER 15.08 (BUILDING CODE) OF TITLE 15 (BUILDINGS AND CONSTRUCTION) OF THE MUNICIPAL CODE OF THE CITY OF COLUMBIA, ILLINOIS REGARDING ROOF SHEATHING MATERIALS

WHEREAS, the City Council of the City of Columbia, Illinois has determined it is necessary and appropriate and in the public interest to amend Section 15.08.020 (Additions, Insertions and Changes) of Chapter 15.08 (Building Code) of Title 15 (Buildings and Construction) in the City of Columbia, Illinois for specific materials that can and cannot be utilized for roof sheathing.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 15.08.020 (Additions, Insertions and Changes) of Section 15.08 (Building Code) of Title 15 (Buildings and Construction) of the City of Columbia, Illinois Municipal Code is hereby amended by adding the following specific materials that can and cannot be utilized for roof sheathing.

Roof sheathing material shall be limited to ½ inch thick minimum, 5 ply fir plywood grade or the ZIP System roof panels with the ZIP System tape. In no case shall particle board (OSB), yellow pine or chipboard be used for roof sheathing.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Agne, and the roll call vote was as follows:




