AN ORDINANCE LEVYING THE TAXES FOR THE  
FISCAL YEAR ENDING APRIL 30, 2008

An ordinance providing for and the making of the tax levy for the twelve months beginning May 1, 2007 and ending April 30, 2008 for the uses and purposes hereinafter set forth for the City of Columbia in the State of Illinois after adoption of an appropriation ordinance number 2551 adopted on April 16, 2007.

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary to raise the sum of \$1,686,163.19 for the purposes set forth below:

**Section 1** That there be and is hereby levied upon all the taxable property within the corporate limits of said City of Columbia, Illinois, as the same is assessed and equalized for State and County taxation for the fiscal year ending April 30, 2008 the sum of ONE MILLION, SIX HUNDRED EIGHTY-SIX THOUSAND, ONE HUNDRED SIXTY-THREE DOLLARS AND NINETEEN CENTS (\$1,686,163.19) for the following specific purposes mentioned in said Appropriation Ordinance and in the respective sums as follows:



Passed by the City Council and deposited in the Office of the City Clerk and approved by the Mayor, this 3rd day of December, 2007.


