ORDINANCE NO. 3128

AN ORDINANCE APPOINTING JAMES MORANI AS CITY ADMINISTRATOR, BUDGET OFFICER AND HEALTH OFFICER OF THE CITY OF COLUMBIA, ILLINOIS, EFFECTIVE OCTOBER 20, 2014, AND ESTABLISHING THE ANNUAL SALARY FOR THOSE POSITIONS

WHEREAS, pursuant to City of Columbia, Illinois ("City") Ordinance No. 3098, approved by the City Council on May 5, 2014, Albert G. Hudzik ("Hudzik") was appointed to the City Offices of City Administrator, Budget Officer and Health Officer (for the City's fiscal year beginning on May 1, 2014) by the Mayor with the advice and consent of the City Council; and

WHEREAS, pursuant to City Ordinance No. 3100, the salary of the City Administrator, Budget Officer and Health Officer, as well as the allowance to reimburse the office related expenses of those positions, was approved by the City Council on May 5, 2014; and

WHEREAS, on May 19, 2014, Hudzik submitted a letter to the Mayor and City Council informing them of his decision to retire as City Administrator, which correspondence included his resignation from that position (including the office of Budget Officer, since the City Administrator also serves as the City's Budget Officer), effective upon the appointment of the City's next City Administrator; additionally, Hudzik has tendered his resignation as the City's Health Officer upon the appointment of a successor to that position; and

WHEREAS, after receiving applications and conducting interviews for the City Administrator's position, on August 18, 2014 the City Council approved City Resolution No. 07-2014, which approved an Employment Agreement for James Morani ("Morani") to serve as the City's next City Administrator ("Employment Agreement"), which Employment Agreement has an effective date of October 20, 2014; and

WHEREAS, said Employment Agreement contains provisions setting the salary and expense reimbursements due Morani for serving as City Administrator.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Columbia, Illinois, as follows:

Section 1. Appointment of James Morani to City Offices.

James Morani is hereby appointed as the City Administrator, Budget Officer and Health Officer of the City of Columbia, Illinois, effective October 20, 2014.

Section 2. Salary/Benefits of James Morani.

Effective October 20, 2014, and pursuant to the terms and provisions of the Employment Agreement (i) the salary of James Morani in his capacity as City Administrator, Budget Officer and Health Officer of the City of Columbia, Illinois, is hereby changed from the amount appearing in City Ordinance No. 3100 for those offices, to an annual amount of \$88,000, until otherwise changed by ordinance; and (ii) the benefits and reimbursements due James Morani shall be as set forth in the terms and provisions of the Employment Agreement and the City's Municipal Code.

Section 3.

All ordinances, resolutions, or orders of the City in conflict herewith, to the extent of such conflict, are hereby repealed.

Section 4.

This ordinance shall be in full force and effect following its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Huch, and the roll call vote was as follows:


