1. Zoning Code Variance to Steve and Brandy Menning

Mr. Osterhage presented the variance request to the Council. Mrs. Brandy Menning addressed the Council and stated the existing deck already violates the City's zoning code. Mr. Osterhage explained there were oversights prior to his employment and building permit plans frequently did not include the decks on them, but were still being built. Mr. Osterhage stated the neighbor two (2) lots down from this property has a deck that encroaches 12' into the easement. It was agreed to forward this issue to Committee for further review and discussion.


