**CITY OF COLUMBIA, ILLINOIS
ORDINANCE NO. 3181**

**NAMING "SOCCER PARK ROAD"
WITHIN THE CORPORATE LIMITS OF
THE CITY OF COLUMBIA**

WHEREAS, the City of Columbia(hereinafter, the City) maintains a particular unnamed road within the corporate limits of the City; and

WHEREAS, the road runs generally in an east/west direction, the far west terminus being an intersection with Southport Drive and the far east terminus being the Soccer Park located north of Palmer Road and parallel to Admiral Parkway; and

WHEREAS, the City Council believes the heretofore unnamed road should be named "Soccer Park Road;" and

WHEREAS, the City Clerk should be directed promptly to notify, in writing and by certified or registered mail, (1) the election authority having jurisdiction within the City of Columbia, (2) the branch of the United States Post Office serving the City of Columbia, (3) the Columbia Fire Protection District, and (4) the Monroe County 9-1-1 Coordinator, of this naming of "Soccer Park Road;" and

WHEREAS, the naming of "Soccer Park Road" should take effect thirty (30) days after the City Clerk deposits in the United States mail at the Post Office in Columbia, Illinois, all of the certified or registered letters to the entities and person described above;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, as follows:

- Section 1. The foregoing recitals are incorporated herein as findings of the City Council of the City of Columbia, Illinois.
- Section 2. The heretofore unnamed City road, which runs generally in an east/west direction, the far west terminus being an intersection with Southport Drive and the far east terminus being the Soccer Park located north of Palmer Road and parallel to Admiral Parkway, is hereby named "Soccer Park Road." (A map indicating the location and road direction of "Soccer Park Road" is attached as Exhibit A, and incorporated into this ordinance.)
- Section 3. The City Clerk shall promptly notify, in writing and by certified or registered mail, (1) the election authority having jurisdiction within the City of Columbia, (2) the branch of the United States Post Office serving the City of Columbia, (3) the Columbia Fire Protection District, and (4) the Monroe County 9-1-1 Coordinator, of this naming of "Soccer Park Road."
- Section 4. The naming of "Soccer Park Road" shall take effect thirty (30) days after the City Clerk deposits in the United States mail at the Post Office in Columbia, Illinois, all of the certified or registered letters to the entities or person described in Section 3 above. The City Clerk shall obtain from the postmaster dated receipts for the mailing of the certified or registered letters, and shall permanently attach those dated receipts to the last page of this ordinance.
- Section 5. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Holtkamp, and the roll call vote was as follows:




