II. Purpose

Alderman Ebersohl explained the Public Hearing was scheduled to hear comments, input, and discussion on the proposed Redevelopment Plan and Project, Designation of the Main Street Abbey TIF Redevelopment Project Area, and Adoption of Tax Increment Financing.

III. Public Comments

Mr. Paul Ellis provided a brief summary of the TIF District and the requirements for the public hearing.

Mayor Hutchinson inquired if there were any comments from the public.

Dr. Segobiano, Superintendent for the Columbia School District, addressed the hearing by stating the School Board does support the proposed project but wants to ensure the Council works with the School Board to address revenue issues that might arise if occupants of any of the apartments within the TIF District include students of the school district. Mr. Bruckert stated the City is aware of the this situation and it will be addressed with the School District.

Mr. Michael Kish stated the future belongs to dreamers and this project will benefit the City by preserving the historic nature of the area while improving Main Street. Mr. Kish added this development will serve as an example to other developers.

Mr. Joe Sander stated he owns property across the street from the property and has some concerns about parking around the property and inquired how the developer is going to address parking issues. Mr. Greg Crawford stated that while parking has always been an issue, he is going to provide additional parking on the property and is always looking for ways to improve parking around the property.

Mr. Ellis reminded everyone in attendance the public hearing was to hear comments about the proposed TIF District and there will be other opportunities, such as the zoning review, to address parking type issues.

Mr. John Whitworth stated that he lives close to the property and while he did not always agree with TIF districts, he now has a better understanding of the benefit of a TIF and thinks this is a great project. Mr. Whitworth added parking is already an issue during special events, such as the Parish Picnic, ball games, and parades.




Mayor Hutchinson inquired if there were any comments from the Council. There were none.




