1. Employee Health Insurance Renewal - MRCT Presentation

Holley Maher and Pete Shemetulskis of MRCT presented a summary of the City's current insurance plan. Ms. Maher stated there is a 14% increase in last year's plan because submitted claims are trending above the national average. Mr. Morani stated part of this is due to switching plans in the middle of the year resulting in only six (6) months of claim data. Mr. Morani then explained the current plan with BCBS of Illinois had a separate out of pocket maximum for prescriptions and as a result, the City will look into offering an HRA in the next plan year. Mr. Morani then explained that MRCT has offered to meet with employees to help manage and educate prescription claims. Ms. Maher recommended the City renew the plan as is and suggested quarterly visits by MRCT, along with initiating some employee training programs to assist with health education.

2. Employ Emily Fultz as Director of Community Development


