AN ORDINANCE AMENDING SECTION 10.44.010 (PROHIBITED PARKING ON CERTAIN PUBLIC STREETS) OF THE MUNICIPAL CODE OF THE CITY OF COLUMBIA, ILLINOIS BY ADDING A SECTION OF SOUTH RIEBELING STREET

WHEREAS, the City Council of the City of Columbia, Illinois has determined that it is necessary and appropriate and in the public interest to amend Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) in the City of Columbia, Illinois by adding the east side of South Riebeling Street, beginning at a point 80 feet from the intersection of Centerville Road, then northwesterly for a distance of 130 feet.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. Section 10.44.010 (Prohibited Parking on Certain Public Streets) of Title 10 (Vehicles and Traffic) of the City of Columbia, Illinois Municipal Code is hereby amended by adding

81. On the east side of South Riebeling Street, beginning at a point 80 feet from the intersection of Centerville Road, then northwesterly for a distance of 130 feet (the area adjacent to St. Paul Lutheran Church Cemetery).

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form, as provided by law.

Alderman Ebersohl moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Roessler, and the roll call vote was as follows:






