ORDINANCE NO. 2681

**AN ORDINANCE TO AUTHORIZE A CONTRACT
BETWEEN EMERGENCY SERVICES SUPPLY AND THE
CITY OF COLUMBIA, ILLINOIS FOR THE PURCHASE OF
A 2008 OSAGE CUSTOM SUPERWARRIOR
AMBULANCE**

WHEREAS, the City Council of the City of Columbia, Illinois (the "City") has found and determined and does hereby declare that it is necessary and appropriate the City purchase an ambulance for use by the Columbia Ambulance Department; and,

WHEREAS, the City Council of the City has chosen Emergency Services Supply of St. Louis, Missouri as the appropriate company from which to purchase the apparatus and equipment; and,

WHEREAS, it is necessary and appropriate this Ordinance be enacted for the use and purpose of authorizing the contract to purchase the aforementioned apparatus and equipment.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

Section 1. The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the City Council of the City of Columbia, Illinois.

Section 2. The City Council of the City of Columbia, Illinois does hereby authorize and direct the Mayor to purchase the ambulance described above in the preamble of this Ordinance (and as is more particularly described in Exhibit 1, dated August 21, 2008, attached hereto).

Section 3. The Mayor is hereby authorized and directed to make and enter into said contract with Emergency Services Supply in the form attached hereto, which is hereby approved as to form, and in as many counterparts as the Mayor shall determine; and, the City Clerk is hereby authorized and directed to attest the same and affix thereto the corporate seal of the City.

Section 4. This Ordinance shall be in full force and effect from and after its passage by the City Council and approval by the Mayor, as provided by law.

Alderman Stumpf moved the adoption of the above and foregoing Ordinance; the motion was seconded by Alderman Row, and the roll call vote was as follows:


