AN ORDINANCE AMENDING SECTION 18.115 OF THE CITY OF COLUMBIA  
MUNICIPAL CODE TO ESTABLISH A FEE FOR MOBILE FOOD VENDORS

WHEREAS, the City of Columbia ("City"), Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

WHEREAS, the City Council of the City of Columbia ("City Council") previously adopted Section 18.115 of the City of Columbia Municipal Code ("City Code"), establishing fees for Business Licenses; and

WHEREAS, Section 18.115 of the City Code does not currently provide a fee for mobile food vendors; and

WHEREAS, the City now desires to amend Section 18.115 of the City Code to add a fee for mobile food vendors.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Columbia, Illinois, as follows:

**Section 1.** That the preceding recitations in the upper part of this Ordinance are realleged, restated and adopted as paragraph one ("1") of this Ordinance.

**Section 2.** That Section 18.115.067 shall be added to the City Code and shall read as follows:

"18.115.067 Mobile Food Vendors

**Section 3.** This Ordinance shall take full force and effect after passage, approval, and publication in pamphlet form.




