E. License, Insurance Claims, CEMA, and Contracts Committee

Minutes of the License, Insurance Claims, CEMA, and Contracts Committee meeting held Monday, January 12, 2009 were presented to the Council for approval.

Alderman Unnerstall stated he did not think there was a need to have the Council take action on all four of the motions made in Committee. Alderman Hejna stated she did not see the reason for a motion to require staff to follow an existing ordinance. Mr. Adams stated it would be a way to send a message that the ordinance will be followed. Alderman Niemietz stated the entire issue of legal fees needs to be reviewed closely in order to identify how it affects the day to day operations of the City, especially since there could be a 2 - 3 week lag in some months if legal assistance is required. Alderman Niemietz

added that prior to Mr. Traxler's departure; he coordinated the need for seeking legal counsel on City issues. Alderman Hejna stated she did not believe there would be a 2 - 3 week lag, and if necessary, a special council meeting could be called. Alderman Unnerstall stated the Council could look at the existing code, but he is opposed to changing the existing code because it provides checks and balances for authorizing outside legal counsel, as in the use of the labor attorney. Alderman Unnerstall added there was a blatant abuse of the labor attorney when Mayor Hutchinson had a private citizen investigated. Mayor Hutchinson stated it all was a lie and he never directed Mr. Weisman's firm to investigate a citizen. Alderman Niemietz stated legal issues need to be addressed when they arise and each situation needs to be reviewed individually. Mayor Hutchinson stated the department heads are very capable of deciding when they need to engage an attorney, and in the past, the administration was able to contact the labor attorney for guidance on employment issues. Mayor Hutchinson then cautioned the impact these motions might have with the three bargaining unit contracts. Alderman Unnerstall stated no one is trying to take anything away from the department heads, but this action might force them to make decisions without involving the labor attorney. Alderman Niemietz stated the Council needs to understand how this whole process evolved and explained that in the past, when labor and personnel issues surfaced, Mr. Adams was not always comfortable addressing them because of the expertise required in labor law to resolve many of the issues. Alderman Hejna stated the expenses for the labor attorney are out of hand and need to be reined in. Alderman Unnerstall stated there has been an abuse of the use of the labor attorney and the existing ordinance needs to be followed.

Alderman Ebersohl inquired how any of the proposed motions would help the City respond quicker to personnel issues. Alderman Unnerstall stated the city would have a list of cheaper firms that could provide the same level of service.

Chief Edwards stated he has contacted Mr. Weisman several times in the past based on Ordinance No. 2508, which authorized the Chief to contact the labor attorney regarding police department personnel issues. Chief Edwards then explained that per the bargaining unit contract, he is responsible for disciplinary suspensions up to five days, and the Police Board is responsible for suspension greater than five days and the Council only gets involved if the officer files a grievance, then Step 2 of the grievance procedures allow the matter to go before the City Council. Chief Edwards also stated items placed in an officer's personnel file can only be viewed by the Chief of Police, the Deputy Chief, and the Police Board. Alderman Unnerstall stated he understood the situation, but stated the ordinance is quite clear about who can contact the labor attorney. Chief Edwards stated passing these motions could be a violation of the FOP Contract and the FOP has contacted me and told me they will have an issue if these motions are passed, or if police personnel issues are brought before the Council before action can be taken. Alderman Oberkfell stated he agreed with the Chief and personnel issues are very sensitive. Alderman Oberkfell then stated he is more concerned about how funds are being expended. Alderman Hejna stated she has read the FOP contract and will have to read it again, but the police department is one of the largest users of the labor attorney. Alderman Hejna then stated the Council will need to review Ordinance No. 2508 since the aldermen were elected to know what is going on. Alderman Unnerstall stated there is a way to satisfy all parties and suggested the Chief could continue to work the personnel issue, but the Council would have to approve the use of outside legal counsel. Chief Edwards stated that when a citizen makes a formal complaint against an officer, there is a 50/50 chance it will result in the need to contact Mr. Weisman. Alderman Agne inquired if the intent is to select a new labor attorney to be used for all personnel issues going forward, or if the Council would be going through this process every time a personnel issue arises. Alderman Unnerstall stated the intent is to have a list of attorneys available to provide services each time an issue surfaces. Alderman Niemietz stated this is not the time to address this issue.

1. Research Legal Firms

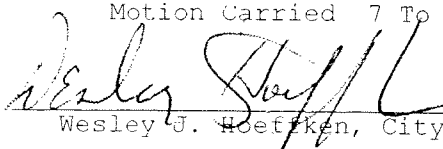

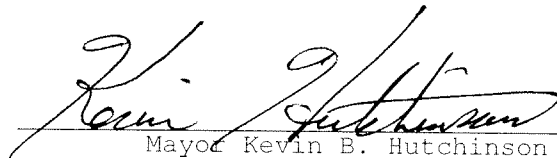
